3 Once your unit has been picked up by our vendor, we'll mail you a \$75 rebate, and you'll be saving money on future electric bills while reducing greenhouse gas emissions!

EARNING THE ENERGY STAR®

- ENERGY STAR®-qualified refrigerators require about half as much energy as models manufactured before 1993. They provide energy savings without sacrificing the features you want.
- ENERGY STAR®-qualified refrigerator models use high efficiency compressors, improved insulation, and more precise temperature and defrost mechanisms to improve energy efficiency.
- ENERGY STAR®-qualified refrigerators use at least 15% less energy than required by current federal standards, and 40% less energy than the conventional models sold in 2001.
- ENERGY STAR®-qualified freezers use at least 10% less energy than required by current federal standards.
